Background

Best practices suggest a Board of Directors with 7-9 members. Smaller boards are more effective, more agile and focus on strategic priorities better. Fewer members communicate more effectively and yield higher quality decisions in a more timely and economic manner.

Working Map Proposals

Attached for your consideration, review, and comment are three map proposals designed to simplify and streamline ACBL governance.

Details


- The two 8 Zone proposals assume a 9th voting member elected from the Board of Governors.
- One 8 Zone proposal requires no District Boundaries be moved.
- The second 8 zone proposal separates Canada and Bermuda into one zone. This means District 20 would grow from Alaska and Washington and D17 would grow from the USA members in District 18. Other placement of these members is possible.
- The 9 Zone proposal offers the lowest variance from the average District population (and a much smaller range in membership than today's 25 Districts). At this point, please familiarize yourself with the attached maps for details, clarity, zone population, and variance from average zone population

What we address

- 1) A structure consisting of 8 or 9 zones.
- 2) Each Zone comprised of existing Districts in two of the three proposals.
- 3) One proposal creates a Canada & Bermuda Zone by moving boundaries in D 18,19, and 20. The gain from the redistricting is simplification of business and tax law across national borders.
- 4) Balanced to minimize the variance in member population.
- 5) Each of the 8 zone proposals would have a 9th member elected from the Board of Governors.
- 6) The 9 zonal proposal offers the lowest variance in average district population.
- 7) With all three proposals we have provided membership data as of 25 OCT 2018 to show zonal membership population totals.
- 8) Annual cost savings of \$225,000 in savings directly relate to reduction in size of BoD.

What we do not address

- 1) How to transition the current board to the new structure.
- 2) How elections should be held for the new positions.
- 3) Whether we need an executive board of consulting professionals in business skills appropriate to the ACBL business size and mission.
- 4) Whether we need Stakeholder representation on the Board of Directors.






9 Zones – No Change in District Boundary
